We are thankful for the streak of good weather allowing our crews to continue with some projects and bring others to conclusion. The electric service is just about finished to the Gathering Place from the street. Ohio Edison has dropped off a pull box and pad for the transformer. As of this printing, Tank Pro is grading both inside and outside the building and are setting in the pull box and transformer pad. Ohio Edison is scheduling the installation of a new pole at the street. The grading is completed inside the building, the new electrical conduits are buried and gravel poured and leveled. The immediate areas around the building, including the patio and parking lot have also been graded and the stone installed. Haines Electric is working to get the electrical work coordinated with Ohio Edison, and as soon as OE completes the high voltage work, Haines will have the lights on in and around the building.
